Entries will not be considered eligible unless this Disclaimer has been fully completed and signed.

Participant Acknowledgment and Agreement

By signing this document, the undersigned Participant (and Parent/Legal Guardian, if the Participant is under 18 years of age) acknowledges that they have read, understood, and agreed to the terms set forth below.

1. Originality, Ownership, and Content Responsibility

The Participant confirms and represents that:

- The submitted video is original work created by the Participant or Team and has not been copied, plagiarized, or derived from unauthorized sources.
- The submission does not infringe any copyright, trademark, intellectual property rights, privacy rights, publicity rights, or any other legal rights of any third party.
- All music, audio, images, footage, graphics, text, and other materials used in the video are original, properly licensed, royalty-free, or used with permission from the appropriate rights holders.
- All identifiable individuals appearing in the video have provided voluntary and informed consent for the use of their image, voice, and likeness. For any individuals under the age of 18, valid consent has been obtained from a parent or legal guardian.
- The Participant assumes full responsibility for the legality, accuracy, and use of all content included in the submission.

Artificial Intelligence (AI) Use, Disclosure, and Responsibility

In addition to the above, the Participant acknowledges and agrees that the use of artificial intelligence (AI) tools is permitted; however, the Participant assumes full legal responsibility for all AI-generated or AI-assisted content included in the submission.

The Participant further represents and warrants that:

- Any AI-generated or AI-assisted content is lawful and does not violate any applicable laws or regulations.
- Such content does not infringe upon any copyright, trademark, intellectual property, privacy, publicity, or other legal rights of any third party.
- AI-generated content does not replicate, imitate, or derive from protected works, identifiable individuals, or proprietary materials without proper authorization.
- All AI-generated elements, including but not limited to video, images, audio, voice, text, or likeness, are original, properly licensed, royalty-free, or used with explicit permission where required.
- All identifiable individuals appearing in the video, whether captured in real footage or generated, modified, or simulated using AI, have provided valid consent. For individuals under 18, written consent from a parent or legal guardian has been obtained.

- Likes received outside the official voting period will not be counted.
- Artificial or fraudulent engagement is strictly prohibited, including but not limited to:
 - bots
 - purchased likes
 - fake or spam accounts
 - coordinated engagement groups
 - automated engagement services
- The Organizer reserves the right to review, verify, investigate, and invalidate suspicious engagement activity.
- The Organizer also reserves the right to adjust or override results in cases of suspected manipulation, unfair advantage, or technical irregularities.
- Engagement records maintained by the Organizer shall be considered final.

4. Release and Limitation of Liability
